About MBA/PGDM in IEV Program and Course Structure: MBA/PGDM in IEV is an incubation-centric program to train, nurture and create a new generation of tech-entrepreneurs, social entrepreneurs, family-business entrepreneurs, intrapreneurs (incubation managers, policy entrepreneurs) from academic institutions and building a pipeline of quality innovations and business plans ready for incubation units to support. In the 2nd year, the student innovators and entrepreneurs are expected to specialise and engage in various action learning tracks to apply their entrepreneurial skills to start their enterprise and (or) become intrapreneurs.
